Content Dimension and Related Principle:	Mathematics, Principle 6: Instruction should include strategies for solving word and algebra problems that are based on common underlying structures.
Implementation Goal:	By November 1, 2016, all math teachers will regularly implement a common "attack strategy" designed for systematically solving word problems.
Desired Student Impact:	By providing students with strategies to solve math word problems (principle 6), and our focus on Principle 5 (see separate Action Plan), we expect mean RIT scores of each grade level to increase by 5 points on the NWEA MAP Test.
